I'm excited to share some important updates regarding our adoption process. We have developed a new provision called 'seniority matrix' for Prospective Adoptive Parents habitually residing in India. This will enable PAPs to see the number of children awaiting adoption as per their health category and age groups in the States/Zones opted by them. Apart from existing 5 types of adoption under the Juvenile Justice Act 2015 (amended in 2021) and Adoption Regulations 2022, children already in foster care have been facilitated to be adopted by foster parents depending on their legal status. Further, to encourage non-institutional care, Foster Care guidelines is being redrafted and several prospective foster parents have been enabled to register online on the CARINGS portal. A large number of CWCs have been connected through CARINGS portal for monitoring status of children.

These updates aim to streamline our adoption process, ensuring efficiency and transparency for all the involved parties. These enhancements reflect our commitment to facilitate a smooth adoption process while prioritizing the best interests of both the children and prospective parents.

Thank you for your devoted efforts to bring positive change to the lives of children across the country.

CARA organised Facebook LIVE session on 27 February 2024 in which around 400 PAPs participated and more than 300 queries were resolved














