Subject: Online Platform for Foster Adoption on CARINGS

This is to advise you that the new Foster Adoption Platform has gone live on CARINGS at the DCPU/SARA level. As a result, all SARAs are requested to direct DCPUs to process such cases via the CARINGS portal, where children are already in Foster Care with Foster Parents and meet the qualifying criteria.

2. The Foster Adoption platform is visible on the dashboard at DCPU/SARA level. Process of uploading the application on online platform is at under:

Step I: Application to be uploaded with requisite documents at DCPU level to verify the documents and forward it to the respective SARA;

Step II: SARA to verify details and forward the application to CARA;

Step III: CARA to finally approve the application followed by issuance of pre-approval letter.

3. Further, all DCPUs are requested to upload all such cases on the online platform at the earliest.
