This is with reference to High Court Juvenile Justice Committee (JJC) meeting held on 2.11.2018 on the aforesaid subject matter.

As per the earlier directions of JJC, proper response in compliance with the directions of Hon'ble High Court of Madhya Pradesh in the aforesaid matter has not been received from MWCD, Steering Committee CARA, and State Government, DWCD Bhopal, SARA.

Hon'ble Chairperson JJC has observed that officials of the aforesaid departments are not complying with the directions of Hon'ble High Court of Madhya Pradesh, it seems that they are not interested to follow the directions of Hon'ble High Court. Hon'ble Justice Shri G. S. Ahluwalia, Member JJC has stated that one more opportunity may be given to the officials of aforesaid departments to give their response before the contempt proceedings be initiated.

After perusal and discussion, JJC has resolved as follows:

*'One more opportunity may be given to the officials of MWCD, Steering Committee CARA, and State Government, DWCD Bhopal, SARA to give their response with regard to compliance with the directions of Hon'ble High Court of Madhya Pradesh in Civil Revision No.258/2017 and 260/2017 in order dated 12.02.2018 before the contempt proceedings be initiated against them.'*

Accordingly, in this regard, you are directed to comply with directions of Hon'ble High Court of Madhya Pradesh in Civil Revision No.258/2017 and 260/2017 in order dated 12.02.2018 as per aforesaid resolution of the JJC and send detail action taken report within 30 days.

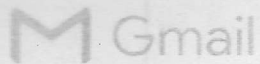

**Agenda: Response to the Hon'ble High Court of Madhya Pradesh in the Case CR 258/2017 & 260/2017 required to be Submitted against Memo No Q/RJ-I/JJC/342 dated 22 Nov 2018.**

1. The directions of Hon'ble Court of MP (attached as **Appendix A**) were discussed in the 13<sup>th</sup> Steering Committee Meeting held on 23<sup>rd</sup> Mar 2018 (attached as **Appendix B**). Based on the discussions and with the approval of the Steering Committee, the Ministry had forwarded its submissions (attached as **Appendix C**) required as per the directions of Hon'ble Court vide order dated 12.02.2018 in the Case referred in the Agenda.

2. As per the earlier decision and response to the Hon'ble Court, an Inquiry Committee was set up to investigate the cases against the SAA Udaan, Bhopal which submitted it's response to the Steering Committee during its 17<sup>th</sup> Meeting held on 15 Oct 2018 (attached as **Appendix D**). The report was accepted by the Steering Committee and *it was decided that further as per law as recommended, be taken by the State Government for which directions be passed to the State Government.* As per the decision of the Steering Committee, the Ministry issued an Order to the State Government vide Order No CW-II-26/5/2018-CW-II dated 01 Nov 2018 (attached as **Appendix E**).
