## **Subject: Zone-wise virtual training for Chief Medical Officers- reg.**

This is in reference of O.M of even no. dated 12/12/2022 and letter vide file no. CARA-MISC/120/2023 (106476) dated 29/03/2023 regarding registration of Chief Medical Officers (CMOs) on CARINGS portal and the subsequent pendency at their level.

2. As you are aware, CMOs have been entrusted to declare the health status of the children registered on CARINGS as normal or having special needs as provided in the **Schedule XVIII and III (Part E)** within a period of fifteen days. The same has been facilitated through CARA's online portal which is operational w.e.f 10/11/2022. It is brought to the notice of CARA that all concerned officials are facing technical and procedural difficulties to adhere to their roles and responsibilities.

3. Therefore, this office is organizing a zone-wise virtual training for the CMOs, office bearer of SAAs and DCPUs with Medical Expert of All India Institute of Medical Sciences (AIIMS) who will apprise about the Medical Examination Report (MER) of the children to adopted, particularly on the classification of Special Needs children.

4. State Governments may kindly ensure participation of their respective SARA, SAAs, DCPUs and CMOs in the training programme.
